FOHOWAY Calculation Period Adjustment Notice

In order to better adapt to the business hours of banks and other social realities, and promote business development, starting from the bonus month of July 2023, FOHOWAY will implement the new weekly calculation period: **From Wednesday to next Tuesday.**

For example, the first bonus week of July 2023 is from 5th July, 2023 (Wednesday) to 11th July, 2023 (Tuesday).

Weekly bonus: The bonus generated by the sales in bonus week N will be officially deposited into the e-wallet account on Friday of bonus week N+2.

For example, the weekly bonus generated by the sales in the first bonus week of July 2023 (5th July to 11th July, 2023) will be officially deposited into the e-wallet on Friday of the third bonus week of July 2023 (21th July, 2023).

The withdrawal process and date remain unchanged.

The calculation period adjustment is applicable to FOHOWAY branches in Indonesia, India, and Myanmar.
